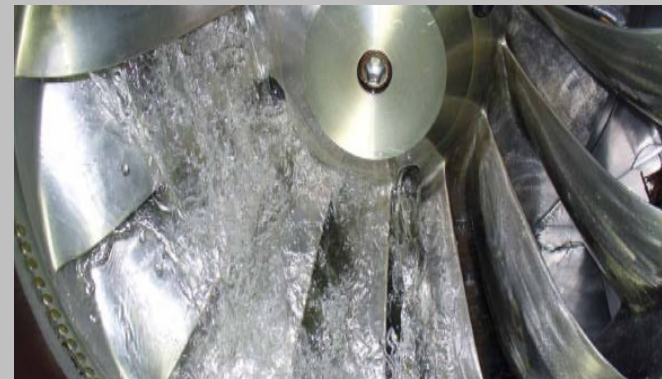

We represent some european producers of biogas plants.

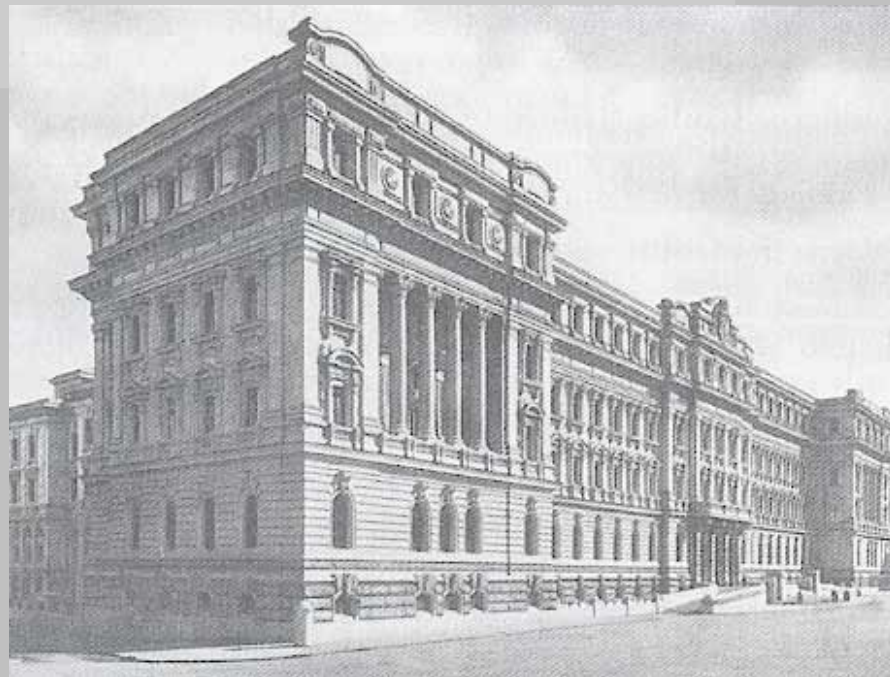
